ABOUT JALA

Jacksonville Area Legal Aid (JALA) is a 501(c)(3) non-profit organization that provides civil legal services to low-income people in northeast Florida. JALA has been in existence since the mid-1930s and has evolved into a mid-sized law firm with three locations: downtown Jacksonville, Green Cove Springs, and St. Augustine. JALA provides full representation in a broad range of substantive areas including, for example, consumer, family, housing, immigration, landlord/tenant, public benefits, and community development. JOB DESCRIPTION

Law student interns provide assistance in a variety of ways that increases JALA's capacity to serve the underserved and vulnerable. Depending on the needs of the substantive units, interns may be involved in client interviewing both in person and by phone; managing cases and learning to use the electronic case management system; identifying legal issues and determining relevant case facts. Interns may assist with research and data analysis. They may accompany attorneys to court and draft documents. Certified Legal Interns (CLIs) may have the opportunity to advocate for clients in court with attorney supervision. Interns gain a good understanding of public interest law and poverty issues. The selected student will be an employee of JALA; all hiring and employment decisions will be made by JALA.

As part of the internship, the selected student will be expected to submit to JWLA three (3) write-ups of their work at JALA (while maintaining client confidentiality) and photo(s) for publication on the website, social media, and the newspaper.

JWLA is a chapter of the Florida Association of Women Lawyers (FAWL). Students are not required to be members of JWLA to apply, but preference will be given to students who are FAWL members. Learn more about JWLA membership at www.JWLA.org and FAWL membership at www.FAWL.org.

SCHEDULE AND PAY

This internship is a paid part-time position at Jacksonville Area Legal Aid (JALA) in downtown Jacksonville. The position will be 16-20 hours per week for 10-12 weeks during Summer 2022 (May to August) at \$10 per hour and will include parking.
